NOTIFICATION

Sub: COMEDK UGET 2015 – Conduct of extended third round
of counselling

The third round of COMEDK counselling for Medical / Dental admissions for the year 2015-16 was concluded on 15.09.2015. The Hon'ble High Court of Karnataka in its order dtd. 28th September 2015 in W.P. No. 41899-41900/2015 (EDN-MED-ADM) and in W.P. No. 41398 / 2015 (EDN-MED-ADM) has directed the respondents therein to include the name of Shridevi Institute of Medical Sciences & Research Hospital for Undergraduate course for MBBS, and Vokkaligara Sangha Dental College and Hospital for Undergraduate course for BDS, so that the petitioner-colleges could admit students both from the Government quota as well as from their quota", which would be subject to the result of the writ petition. Similarly, the Hon'ble High Court of Delhi in W.P No. (C) 9348/2015 and CM No. 21668/2015 dated 29th September 2015 has directed the respondent therein to include the name of Father Muller Medical College for Undergraduate course for MBBS so that the petitioner-colleges could admit students both from the Government quota as well as from their quota", which would be subject to the result of the writ petition.

Accordingly, the institutions which are members of COMEDK have requested to conduct an extended counselling for COMEDK students for Medical and Dental UG admission during 2015-16 based on the individual merit published on 8th June 2015. As per the consensual agreement dtd. 29th May 2015 between the Government of Karnataka and the Association of Colleges, 60 MBBS seats in the Shridevi Institute of Medical Sciences & Research Hospital, 27 MBBS seats in Father Muller Medical College and 18 BDS seats in Vokkaligara Sangha Dental College and Hospital will have to be filled through COMEDK merit route.

Accordingly, it is proposed to hold an extended third round of counselling to fill up the said seats on 30th September 2015 as per the detailed counselling schedule enclosed as Annexure.

As this is an extended round of counselling, such of those candidates who are already holding a Medical seat, **repeat, Medical seat secured through COMEDK UGET 2015 counselling process** are not eligible to participate and select medical seat; similarly such of those candidates **who are already holding dental seats likewise secured earlier through COMEDK Counseling** are not eligible for selection of dental seats notified herein. This is in the interest of equity, justice and fair play for all those candidates who are waiting for the seats. All other eligibility criteria published by COMEDK earlier vide Notification dtd. 13.06.2015 in the counselling process document and ready reckoner dtd. 24.06.2015 shall apply to the candidates who attend this extended round. Further, it shall be the responsibility of the candidates participating in this counselling to procure and submit all original documents and pleas such as original documents have been submitted to any other Institutions/Universities/Agencies or other courses etc. are not acceptable. The tuition fee payable is 4,25,000/- (Rupees four lakh twenty five thousand only) for Medical seat and Rs.2,75,000/- for Dental seat in the form of crossed demand draft drawn on a Nationalized bank in favour of COMEDK at Bangalore (refer the process document notified on 13th June 2015).

The candidates are required to **come prepared and get admitted to the college on 30/09/2015** itself without fail; no extension for seeking admission is permissible.
