NOTIFICATION

COMEDK UGET 2015 - Medical and Dental Second Counselling -Eligibility norms for participation, Allotment, Surrender etc.

GENERAL:

As stated earlier, the main philosophy behind counselling for admissions into Professional Institutions is to provide atleast two opportunities so that a candidate who has taken a seat during the first counselling may like to continue with the seat so selected or select some other seat in some other college during the subsequent counselling. At the same time, merely because more than one opportunity is available it does not mean that a candidate can aspire for procuring a seat in multiple institutions. In other words, in the name of a better rank, a candidate shall not participate holding a seat elsewhere. It is in this backdrop that whenever a candidate opts for a confirmed allotment, he/she shall submit all the original documents and produce the same whenever a provisional allotment is sought for.

- 2. However candidates who have selected a seat by submitting their original documents in the following Institutions / Agencies alone may attend the COMEDK Second Round Counseling with one set of attested photocopies of the documents as indicated in para-13 of Process Document notified on 13/06/2015, along with the acknowledgement and the original allotment letter issued by them: This clause is not
- applicable for third round counseling.
 - a) All India Pre- Medical and Dental Counseling (AIPMT)
 - b) Karnataka Examination Authority (KEA)

Note: All other candidates have to show the original documents specified without which they will not be allowed to participate in the counseling.

3. The single window process of seat selection adopted by COMEDK is on the lines of directions issued by the Hon'ble Supreme Court in 1) TMA Pai Foundation Vs. the State (2002) 8 SCC 481, 2) Islamic Academy of Education Vs. the State reported in (2003) 6 SCC 697 and 3) PA Inamdar Vs. the State of Maharashtra reported in (2005) 6 SCC 537. Also the candidate shall note that there are no Agents appointed by COMEDK and the website (www.comedk.org) is the only official website of COMEDK and if any candidate approaches or relies on any other website or organization he/she

will be doing so at his/her own risk and COMEDK is in no way responsible for resultant consequences.

SECOND ROUND COUNSELLING:

4. With the above principles and in continuation of the procedure explained earlier in the Process Document notified on 13/06/2015 and the Ready Reckoner announced in the website on 24/06/2015, COMEDK proposes to hold the second round counselling as between 25/08/2015 to 28/08/2015 (both days inclusive) * since revised to 27th August to 29th August 2015 vide notification dated 21/08/2015. As there will be a third and final round of counselling, there will be no exclusive session either for minority candidates or candidates seeking reservation of Hyderabad Karnataka Region allotments during the second round; all candidates shall participate in the seat selection process based on the order of merit as in the first round. The counselling venue shall continue to be "NMKRV College Mangala Mantapa", 3rd Block, Jayanagar, (near Southend Circle), Bangalore 560 011; the final cutoff ranks during the year 2014-15 has already been hosted on the website and the candidates will refer to them and attend the counselling. The detailed schedule of counselling is available; the candidates are required to check the availability of seats on a daily basis and plan for participation in the counselling. For any disappointment, COMEDK is not responsible.

AVAILABILITY OF SEATS FOR SECOND ROUND:

- 5. The following shall constitute for the availability of seats for Medical and Dental second counselling:
 - a) All seats left unfilled after the conclusion of first round counselling, concluded on 17/07/2015;
 - b) Seats, if any, sanctioned by MCI/DCI as additional intake and allocated by the State Government based on agreed seat sharing formula;
 - c) All seats taken during the first round but surrendered during period as per the notified schedule.
 - d) Any additional seat/s added to the COMEDK as per the desire of the Member Institutions.

Note: Once a seat is selected during the second round, the earlier seat selected by the candidate gets automatically cancelled and would be offered to the next best eligible candidate in the order of merit.

ELIGIBILITY FOR ATTENDING THE COMEDK SECOND COUNSELLING:

- 6. The following shall be the eligibility norms for a candidate to participate in the second round counselling; he/she shall have:
 - a) qualified in the written test and holding a valid COMEDK rank card;
 - b) participated or not during the first round of counselling;
 - c) selected a seat or not and if selected, obtained provisional or confirmed allotment during first round counselling;
 - d) in the event of a confirmed allotment, whether reported to the college or not;
 - e) selected a seat and obtained provisional or confirmed allotment letter during first round counselling and got the said seat surrendered thereafter.

ALLOCATION OF SEATS:

- 7. The following are the norms for allocation of seats:
 - a) As in the first round counselling, a candidate is at liberty to opt for either a provisional or confirmed allotment.
 - b) The candidates holding the confirmed allotments either reported to the college or not may also opt for a provisional allotment after returning the original allotment letter, bank receipt for having deposited the tuition fee and the original verification card issued by COMEDK.
 - c) As there will be a third round counselling, candidates who have taken provisional allotment during first counselling may either continue to hold the said provisional allotment without surrender or converting to confirmed allotment.
 - d) If there is any difference as shortfall in the tuition fee to be deposited on account of deduction towards processing fee or selection of a seat of higher fee, the said shortfall shall be made good through demand draft drawn on a Nationalized Bank, in favour of COMEDK payable at Bangalore. Such demand draft shall confirm to the norms announced earlier in the seat selection process documents published on 13/06/2015.

Note:

- 1) Candidate seeking confirmed allotment shall submit all the original documents indicated at para 13 of page 6 vide seat selection process document notified earlier on 13/06/2015.
- 2) As in the first round, a provisional allotment cannot be utilized for joining the college concerned.
- 3) Candidates holding confirmed allotment letter if reported to the colleges must carry the following documents while attending the second round counseling:
 - i) Photo Copy of the Allotment letter and the Bank receipt for having paid the tuition fee.
 - ii) Original Verification card.
 - iii) Copy of the fee receipt paid at the college.

Surrender policy and conversion of provisional allotment into confirmed allotment after the second counselling:

- 8. The following shall be the policy guidelines:
 - a) A candidate holding either a provisional or confirmed allotment, reported or not to the college concerned, is eligible to surrender the seat after the second round, but before the third round, only before COMEDK.
 - b) Surrenders if made elsewhere, the candidates will not only lose the entire tuition fee deposited with COMEDK but also forfeit their original documents and the said seat will be taken to the third round.
 - c) Surrenders before COMEDK would be accepted only in person provided the same is made by the candidate only and within the period that would be notified separately; acceptance of surrender is subject to production of original allotment letter, bank receipt for having deposited the tuition fee and the original verification card.
 - d) A processing fee of '5,000/- (Rupees five thousand only) would be deducted and the balance refunded through crossed cheque in the name of the candidate only.
 - e) Candidate with a provisional allotment may convert it into confirmed allotment by producing
 - i) original allotment letter;
 - ii) bank receipt for having deposited the tuition fee;

- iii) verification card issued by COMEDK; and
- *iv)* all the relevant mandatory documents in original required for claiming confirmed allotment letter.
- f) Failure to either surrender the provisional allotment letter or convert the same into confirmed allotment during the notified period, the candidate will lose '50,000/- (Rupees fifty thousand only) as penalty and the said seat shall be forfeited and added to the next round of counselling.
- g) There is no provision to issue provisional allotment during the third round and the surrender will not be accepted either during or after the third round counselling.
- The detailed counselling schedule between 25/08/2015 to 28/08/2015 * since revised to 27th August to 29th August 2015 vide notification dated 21/08/2015 is as at Annexure A.
- 10. The terms and conditions set out in the seat selection process document notified on 13.06.2015 shall prevail to the extent not contrary to the seat selection procedures explained as above.
