COMEDK 2017 Medical and Dental PG Courses: Seat selection process pursuant to NEET results(Revised on 09.03.2017)

The Karnataka Professional Colleges' Foundation, comprising of 14 Medical and 24 Dental Unaided Private Professional Colleges has mandated COMEDK to conduct a single window counseling for these institutions so as to fill up over 400 Medical and about 250 Dental PG seats, based on the results of National Eligibility cum Entrance Test 2017. As per the directions of the Hon'ble Supreme Court in W.P. No. 261/2016, admitting authorities will invite applications for Counselling and merit list shall be drawn based on All India Rank. Also, the Apex Court in IA No. 7 & 8 in W.P. No. 76 of 2015 with W.P. No. 314 & 328 of 2015 has given its stamp of approval for time schedule for completion of admission process for PG courses.

The National Board of Examination which has conducted the NEET for Post Graduate Medical and Dental Courses has announced the results on 13th January 2017.

In view of the above, COMEDK hereby invites applications from the eligible candidates to participate in its seat selection process for selecting PG Medical and Dental seats seeking admission in its member institutions during 2017-18. The eligibility criteria shall be as laid down by MCI/DCI including the NEET score.

A detailed calendar of events and the information brochure in this regard will be made available on the COMEDK website from 08.03.2017 and the online application will be available from 09.03.2017. The candidates are advised to make themselves familiarized with the contents in the information Brochure before filling the online application form.

However, an indicative list of original documents necessary for submission mandatorily at the time of counseling by the candidates are as follows:

- 1) Admit card of NEET PG/MDS 2017.
- 2) NEET – PG/MDS 2017 Score Card showing All India NEET PG 2017 Rank/All India NEET MDS 2017 Rank
- 3) Copy of COMEDK Online Application Form for participation in COMEDK PG counseling pursuant to NEET results.
- 4) SSLC or 10th Standard marks card, Passing Certificate or Transfer Certificate for the proof of Date of Birth.
- 5) MBBS / BDS (All Marks Cards).
- 6) Internship Completion Certificate / Certificate for date of completion of internship duly signed by the head of the institution last studied in case of candidates who have not yet completed their internship. (cutoff date for internship completion is 31.03.2017).
- 7) Permanent / Provisional Degree Certificate.
- 8) Permanent / Provisional State / Central Council Registration Certificate.
- 9) Attempt Certificate (If applicable).
- 10) Applicable Caste Certificate issued by the Competent Authority (for Karnataka Candidates only).
- 11) OBC certificate issued by the competent Authority (for Karnataka Candidates only).
- 12) Minority certificate issued by the educational institution concerned (for Christian and Tulu Minority of Karnataka and Non-Karnataka Christian candidates only).
- 13) Residential / Domicile certificate, wherever necessary (for Karnataka Candidates only).
- 14) Parent domicile certificate, wherever necessary (for Karnataka Candidates only).

- 15) Eligibility Certificate for claiming seats reserved for Hyderabad Karnataka Region candidates issued by the Assistant Commissioner of the respective sub-division (applicable for Karnataka Candidates only).
- 16) Anyone of the valid photo ID proof in original:
- i) Passport
 - ii) PAN Card
 - iii) Driving License
 - iv) Aadhaar Card / e-Aadhaar Card
 - v) Voter's ID
