

## CORRIGENDUM TO NOTIFICATION DTD. 30.07.2017

While announcing the revised process for conduct of second extended round for Engineering courses, it was informed that in case of any up- gradation for the candidates who are holding a seat, the earlier allotted seat automatically gets cancelled and will be allotted to other candidates based on merit. In such situation, the tuition fee paid by these candidates will be adjusted to the newly allotted college. Subsequently, a lot of candidates/parents are asking whether the tuition fee paid at college level would be adjusted by COMEDK.

In this regard, it is made clear that only the tuition fee paid at COMEDK i.e. ₹55,000/- would be adjusted to the newly allotted college and not the fee paid at college level since it differs from college to college.

To address this, the Hon'ble Admission Overseeing Committee has already issued directions to the colleges that in case the candidates who are allotted an upgraded seat in the extended second round of counseling, their fees paid at college level along with the original documents have to be returned without any further ado from the earlier allotted college.(Order from the Admission Overseeing Committee enclosed which has been circulated to all colleges)

In view of the above, the candidates may approach the concerned colleges for getting back their fees as well as original documents.
